Life Events

A Life Event is when you have a qualifying event, such as: Marriage, Divorce, Death, Birth, Adoption, Loss or Gain of other Coverage. You have 30 days from the qualifying event date to enter your life event in Workday and make your election changes. The 30 days is governed by the IRS regulations and plan documents. The date of the event is the effective date of the coverage change. How do you make this change? You need to log into Workday and under

Benefits and Pay, select Change Benefits to enter your life event. You will need the supporting documentation, such as Marriage, Birth or Death Certificate or Proof of gained or loss of coverage. You will upload this directly into Workday when you create your Life Event.
